• SUMMARY:

City College Economics Department went for a survey in Tribal majority Village Daronda, Birbhum District, a district with a large concentration of tribal population. Xx students along with 3 faculty made an extensive tour of the village and its surroundings. We talked to 6 women and 2 men from the village and a woman running an eatery by the roadside. Women from Daronda village were all Santhals. 3 were making leaf plates and glasses, 2 were painting houses for an upcoming festival. All of them had job cards, but getting work is a major problem. So all of them work as day labourers in nearby villages. Men also do sundry work like cutting wood etc. We also talked to a woman running an eatery. She lost her all resources during one of the ponji scheme scams as her son was an agent of such an organisation. After that she came up with a small tea stall, which now has developed into a full fledged eatery serving all meals. Her husband mends musical instruments along her eatery. Her major problems are two: a) the land on which her eatery is situated is government land and she can be evicted any day; and 2) lack of loans as she has no collateral to get institutional credit.

The team also visited 2 NGOs (names) working for the upliftment of local poor, particularly tribal population. Both of them are trying to impart various skills, right from better farming, poultry and dairy along with selling the products that they produce. They are also teaching about saving the forests, planting trees and prepare saplings in nurseries.
