On 27.06.2022 principal received a phone call from a student named Sunny Shaw B. Com SEM2 (CBES2022) and wanted to talk to the principal regarding this case.

Accordingly an emergency meeting was called on 28.06.2022. In this meeting, the student Sunny Shaw appeared and submitted a written complain to the Principal. After thorough discussion with the student the committee members were convinced that it was a clear case of misunderstanding between them and ^{so} it is not a case of ragging. Accordingly he (the student) decided to withdraw the case unconditionally. Principal accepted the withdrawal letter from him.

Hence, City College Anti-ragging Committee resolved to stop the matter with an immediate effect as there is no merit to proceed further with the case because it is a case of mere misunderstanding and not a case of ragging.
